RULES AND REGULATIONS

1-9-90 4

1. Name of the Association : Shruthi Sagara Vidhya Samastha
2. Address of the Association: Saraswathi Pura,
Near Mahalakshmi Layout
BANGALORE-560 086.

3. MEMBERSHIP:

- a) Donation of Rs. 1,000/- will be collected from members of the Association.
b) The Admission Fee for each member shall be Rs.2/- only.
c) Each member shall pay Rs.5/- annual or such amounts may from time to time be fixed towards the monthly subscription of the Association and all monthly subscription shall fall due on the first day or within tenth of every month.
d) Any person who has attained the age of about 18 years will be allowed to become a member of the Association.
e) If the subscription of a member is in arrears for three months following without satisfactory explanation to the Secretary his name will be removed and the Executive Committee may reconsider his application for re-admission subject to all the arrears including the Admission fee being paid. The membership shall be terminated on death, the member acting against the character of the Society or the only other reasons stated by Executive Committee.

4. INFORMATION REQUIRED BY MEMBERS:

Any member of the Association may apply to the Secretary for any information as he may require on any matter of the subjects or rules and regulations of the Association.

5. GENERAL AND OTHER MEETINGS:

- 1) A general Body meeting of the association will be held annually during the month of March.
2) The report of the management of the previous years working and the audited account for the one period and proceeding years shall be discussed and submitted for confirmation.
3. A new committee for the coming year shall be elected in the general body meeting.
4) The committee shall generally meet once in one month for which notice of 7 days will be given to the members by Secretary.

5) The President may call for a General Meeting, if he so desire and it shall be on the requisition of the 25% of the members for which 21 days notice shall be given to Sunandamma the members.

6) Voting shall be conducted by show of hand or secret ballot.

7) 21 days clear notice to the ordinary meetings and 21 days clear notice to the Official General Meetings will be given and the subject matter to be discussed shall be distinctly stated in such notice.

8) A special General Meeting shall be convened, if necessary as per section 11(3) of the K.S.R. Act 1960.

6. QUORUM: The quorum of the General Body Meeting shall be 1/3rd of the members.

7. AUDITOR: An Auditor shall be appointed annually appointed and the remuneration shall be fixed by the members of the Annual General Meetings.

8. ACCOUNTS:

a) Official year:- The official year of the Association shall be from 1st January to the end of December every year.

b) The assets and liabilities and the balance sheet of the Association shall be drawn up by the Auditor duly audited, and shall be laid before the annual General body meetings for confirmation.

c) Such balance sheet and the list of committee member shall be fixed with the Registrar of Societies as per 13 of the K.S.R. Act 1960.

9. EXECUTIVE POWERS OF THE COMMITTEE:

The administration and Management of the Association shall vest in the Executive Committee consisting of members including President, Secretary and Treasurer are elected at the Annual General Body meeting of the Association subject to the control of the meeting of the association in the General Body Meeting.

1. PRESIDENT: The president shall act as President the Chairman in the committee and in the absence of the member shall elect any one of the members of Chairman.

2. SECRETARY: He shall have charge of all materials belonging to the Association with the exception of those pertaining to accounts and he shall be the Executive office of the Association.

3. TEASURER: He shall have charge of and keep in safe custody of all days and securities belonging to the Association receive all dues and issue receipts, maintain the subscription book and true account of the moneys received and spent on behalf of the Association.
10. Any vacancy that may arise in the Executive Committee may be filled in by the remaining committee members.
11. Any member of the Executive Committee being absent for three successive meeting without proper cause shall be cease to a member of the Executive Committee and shall be eligible to be re-elected.
12. The Executive Committee is to meet every month or earlier if there is any business to consider and the earlier-if-these Secretary shall convene such meeting in consultation with the 1/3rd members shall be forms a quorum.
13. The Executive Committee in its meeting shall consider all questions effecting business that may be of interest to the members of the Association and they shall be inform and circulates any information which may be of use and beneficial to the meeting.
14. Alterations of Amendments of the Memorandum of Association shall be made as per Section 9 of the K.S.R. Act 1960.
15. Change of name, rules and regulations shall be made as per section 10 of the K.S.R. Act 1960.
16. The working hours of the Association:
From 8.30 A.M. to 5.30 P.M.
17. The dissolution of the Association if it arises, section 22 and 23 of the KSR Act 1960 shall be followed.
18. Regarding Amalgamation of the Association arises, section 21 of the KSR Act 1960 shall be followed.
19. For all things and matter which have not been specifically provided for therein above.


